

# Common Violations & How To Fix Them! \*\*Reminder, Clagett completes Spring inspections annually\*\*

Our community Covenants, Conditions and Restrictions (CCRs) outline the expectations we as residents have agreed to adhere by. You can find a copy of these CCRs on our web portal. Please take a moment to review your property with respect to the most common violations:

- 1) Trash Cans, Recycling Bins & Yard Waste: Put out no earlier than the evening before pickup & put away the day of pick up. If out of town, ask a neighbor to move your cans & bags on the appropriate days. Do not store on driveways even if "hidden" by parked cars. Yard waste bags should be stored in a garage/porch/backyard, not at the end of the driveway.
- 2) Powerwashing/Siding/Trim/Roofs: Regular maintenance is expected of all homeowners to keep siding and brickwork on homes/sheds free of dirt/mold, as well as keep doors, shutters & house trim painted. Please replace roof shingles and siding as soon as you notice they are missing.
- 3) Lawns & Landscaping: Keep lawns trimmed & weeds to a minimum. Residents are responsible to make sure cut grass on the street/paths is blown back into their yard and trees & shrubs are trimmed so as not to obstruct walking paths or hang over neighbors' yards. Any bulk mulch deliveries should be moved from driveways/yards as soon as possible.
- 4) Driveways: Please remember that driveways should not be used for storage.
